SECTION IV - FIRE AND EXPLOSION DATA

(NON-FLAMMABLE) Welding arc and sparks can ignite combustible. Refer to ANSI Z49.1 for precaution to be taken.

SECTION V – REACTIVITY DATA

HAZARDOUS DECOMPOSITION PRODUCTS: The composition and quantity of welding fumes and gases can be influenced by such factors as the process being utilized, the material being welded, electrode type used, condition of base material being welding on, type of exhaust and the presence of contaminates in the atmosphere.

CARCINOGENIC: Chromium and Nickel and their compounds are listed by the IARC and the NTP as posing a carcinogenic risk to humans.
